Equipment & Facilities Use Policy

To use Access equipment and/or facilities, a person must:

- 1. Be a resident of Pepperell, be a student of North Middlesex Regional High School, or be working with a Pepperell producer.
- 2. Use the equipment/facilities for the creation of non-commercial programming for cablecast on the access channels.
- 3. Be certified by Pepperell Community Media (PCM) to operate the specific equipment.
- 4. Sign the appropriate checkout form for each usage, taking full responsibility for the care of the equipment being used, and the actions of crew and/or guests. If the Access User is a minor, then a parent must sign.
- ➤ Access user will be billed, at the discretion of the PCM Director, for any costs to repair or replace equipment that is not returned in the condition in which it was checked out or used within the studio environment.
- ➤ Equipment is available on a first-come first-served basis. Efforts to accommodate other users are appreciated.
- > Equipment is not available for rent.
- ➤ In the course of access productions, a user shall not represent to any party that he/she, or any other person involved, represents Pepperell Community Media or the Town of Pepperell in any manner.
- ➤ Equipment to be used in our facilities at Cottage Street is available only when a PCM staff member is present; advance scheduling is necessary.
- ➤ Recording media is not provided by PCM; access users will need to provide their own recording media for camera use and for moving files to and from PCM video editing gear.



Producer Training Guides and Certifications

Producer training, provided by a PCM staff member to student producers, covers hands-on training and proficiency testing for PCM equipment to be borrowed and used by the student. A "Training Scorecard", attached, is used by the instructor to record details of the training provided and proficiency acceptance. At this time, training is provided for camera and tripod use, wireless kit use, and very basic video editing computer use. Training in video editing software functionality is not currently provided.

Producer training shall also include a review of PCM policies and forms in the PCM Producer "Package", especially covering requirements for disclaimers and release documents. A copy of the "Package" should be given to the producer.

For camera gear, the PCM instructor shall:

Combine a camera and tripod into one group for training and loan
Present a wireless kit as a separate group for training and loan
Use inventory lists for training check-offs if appropriate
Cover usage, care, safeguarding, and procedures (sign out, sign in, battery charging, etc.)

Discuss media policy – no PCM media is to be used

Maintain records to indicate PCM instructor acceptance of borrower proficiency and training completed

For editing computer use, the PCM instructor shall provide only introductory information limited to:

Account info, log-in, log-off

User specific data storage allocations

Basic software introduction to describe software resources as currently installed and available at PCM; does not include detailed instruction in the use of that software

If needed, the PCM instructor shall provide any additional instructions for general information or compatibility with the PCM cablecasting environment (e.g., file naming conventions, and so forth)

Requirement for the producer to include our disclaimer at end of a video

I agree that the scheduling of this program(s) is at the discretion of Pepperell Community Media, Inc.

As producer / sponsor of this program(s), I state that the program(s) contains no commercial advertising, obscene or indecent material, misappropriation of images without consents if consents are required, direct or indirect solicitation of money, lottery information, libelous / slanderous material, material violating privacy rights or other lawful rights of any person or any entity, violation of trademark, copyright or other intellectual property rights, or material which might violate any local, state or federal law.

I agree that I am solely responsible for the content of this program(s) and am solely responsible for compliance with legal requirements applicable to the content and cablecasting of this program (s) and do not hold PCM, its staff, its employees, its Board of Directors, or the Town of Pepperell responsible for its content or cablecasting or legal compliance in any way.

Disclaimer Policy

Background: Videos cablecast by public access stations are either "sponsored" or "self-sponsored". Sponsored videos provide content from other sources (that is, not directly from Pepperell Community Media), and self-sponsored videos are videos that we record, edit and cablecast on our own. We regard pretty much everything we record on our own to be self-sponsored: all Town meetings, parades, Library events, Senior Center events, Town Administrator's Report, and so forth, as these are Public events.

Many sponsored videos come to us clearly identifying the source (e.g., Middlesex County Sheriff, Sen. Donoghue, Legal Ease, Physicians Focus, Shine Medicare Assistance, Folklorist, etc.), but there are other videos that less clearly identify the sponsor. Our procedure in the past has been that if we are asked to cablecast a video that we have even the slightest concern about, we first require the sponsor to submit a completed Request for Cablecast Form.

Previously we were asked by a Pepperell resident, Keith Marciniak, to help with a video (or videos) about the hazards of electromagnetic fields (e.g., wire-less electronics). He's been working with Cecelia Doucette, an Ashland resident, who has compiled a detailed and well documented description of the issue. Of course, Pepperell Community Media has no knowledge whether this is gobbledy-gook or information useful to the community, and that led us to the decision to also add a disclaimer to any videos like this. Bill August and I drafted the following text (*employees and Town of Pepperell added 04 JAN 2018 by R. Potts*).

Disclaimer Text: The views and opinions expressed in this video are those of the video producer or sponsor and the guests of the producer or sponsor, and do not reflect the official policy or position or views and opinions of Pepperell Community Media, Inc., its staff, its employees, its Board of Directors, or the Town of Pepperell.

Guideline for Applying Disclaimer: Many of the videos we cablecast are "public" events, described above, that we self-sponsor, and a disclaimer is not needed. Many videos from other sources (submittals or downloads) are either videos of public events, or have proper identification and/or disclaimers embedded. We will not attach our disclaimer in those cases.

Any video submitted for cablecast, with a Request for Cablecast form, will have the above disclaimer appended.
